Consignment Agreement

1. The above referenced (consignor) authorizes Diversatech Consignment Sales (the consignee) on behalf of Liquid Estates (Estate Sale Company) to sell and liquidate all of the items provided upon picking up and cleaning out the estate.
2. This agreement is between the consignor and Liquid Estates, but all items will be sold through Diversatech Consignment Sales located at
3. Consignment period is for 120-days. Consignor receives 50% of the selling price for consignments sold and Diversatech Consignment Sales receives 50%.
4. Diversatech Consignment Sales will be actively having open store hours. We will be actively working to market our sales and your item until it sells or it has been in store for more than 120 days. If the consigned items do not sell within the 120 day period, the consignor has the option to sign an extension amendment to the agreement, which adds an additional 30 days at a reduced sale price of 75% off.

5. Discounted Price structure goes as follows: First month items will be sold at full price. Second month will be at 80% of the full listed price. Third month will be at 60% of the full listed price. Fourth month will be at 40% of the full listed price.
6. Diversatech Consignment Sales upon receipt of the consignors items will price and tag all items for sale. All items will be input into our software in which the consignor will be able to track all items sold.
7. Each consignor will be issued instructions on how to create an online account and a way to access their account to view sold items.
8. Diversatech Consignment Sales is not responsible for any damage due to an “act of God”, theft or loss of any items consigned.
9. Pay period is on a monthly basis from the 1st to the last day of the month. Proceeds from all sold items are paid out by the 15th of the following month. We offer the option to have ACH payouts directly to your account, check available for pick up or we can offer a check to be mailed out for a \$2 fee. Consignor shall be responsible for any fees associated with lost checks requested by mail.
10. Diversatech Consignment Sales is not responsible for ACH payouts that were sent out and not received due to a wrong account details being provided.
11. Unclaimed consignor earnings shall be forfeited 120-days after the sale of any consigned item.
12. After expiration of the consignment agreement or signed extension. If the remaining items are not picked up or retrieved by the consignor within 15 days of the expiration period. Diversatech Consignment Sales reserves the right to ownership of any consignments still in our possession.
13. As the sole owner of the items described in this agreement, I am within my legal rights to consign these items.

This agreement (including the documents referred to herein) constitutes the entire agreement among the parties and supersedes any prior understandings, agreements, or representations by or among the parties, written or oral, to the extent they relate in any way to the subject matter of this agreement.
